• Legislative Subcommittee.

- Amanda Thorpe reports:
 - Request for feedback on mandatory consideration of child's preference (age 14). Information not received in time. Committee did not take action. Now tracking and hope to offer input.
 - Presumption of equal parenting time back up for consideration.
 Wants to take issue seriously.
 - Committee has not yet met.
 - Thorpe flagged the following bills to track:
 - HB 2032 expanding domestic partnership to partners of any sex
 - HB 2390 requiring judicial dept. to review custody procedures
 - HB 2398 rebuttal presumption/joint custody
 - HB 2416 modifies procedures for issuing extreme risk
 - *HB 2811* claim dependency exemption
 - SB 312 requiring judicial department to study allocation of parental decision-making
 - SB 313 child's preference (re: custody)

- SB 314 permits accrual of interest on child support only if non-payment is willful
- *SB 315* recreates rebuttable presumption of equal parenting time
- *SB 547* permits courts to consider abuse when determining spousal support
- SB 806 allows obligor to modify life insurance requirements for purposes of insuring child support
- Family Law Newsletter. Editor in chief job description has been distributed.
 - Samantha Benton and Amanda Thorpe:
 - Discussion regarding job description that was circulated
 - Motion to approve editor submissions and allow Samantha & Amanda editorial discretion to make any necessary changes and to get the job description out for publication as soon as possible. Keri Smith seconded. Unanimously passed.

Declaring a Vacancy on FLEC.

- Previously discussed at February 2022 meeting. After our February 2022 meeting, Hon. Erin Fennerty sent email explaining Bylaws and our expectation to participate. Ms. Russell did not respond.
- Hon. Erin Fennerty moved to declare Ms. Russell's position vacant pursuant to the Bylaws. Keri Smith seconded. No discussion. Unanimously passed.
- Laura Eckstein reached out after nominating committee had met and inquired about participating on the FLEC. Ms. Eckstein was active in ONLD's committee. Samantha Benton will reach out to Ms. Eckstein regarding her ongoing interest. Will discuss at next meeting. (Would only fill vacancy left by Russell for the rest of her term.)

• International Law Section CLE Co-Sponsorship.

- Hon Fennerty
 - We were approached by the International Law Section requesting we jointly sponsor a CLE re: elder and child abuse reporting. Speaker secured (Molly Becker – Buckley Law). Will be a hybrid CLE.
 - Would include joint advertising.
 - Monetary contribution estimated cost is \$400 for room (conference room in their building); recording \$1000-\$1500; social hour \$1,500 -\$2,000
 - FLEC would like to know whether our members can attend for free if we sponsored.
 - An answer is needed by April 12th.
 - Discussed conditionally approving for sponsorship for \$500; cannot sponsor alcohol related expenditures.
 - Hon. Erin Fennerty moved to co-sponsor the CLE for \$500, designating our sponsorship only for non-alcohol related expenditures and conditioned upon our membership having the

option of either streaming for free (live-streamed) or view replay for free (if offered). Kristi Skalman seconded. Unanimously passed.
